Session Outline:

Daytime Canskate/Parent & Tot: This is a learn to skate program for preschool children. Skaters will learn the basic skating skills following the Skate Canada badges. If you are not sure if your child is ready to skate on his/her own you may join your child by registering for the Parent & Tot program.

Canskate: This program is for school aged children. Skaters will learn the basic, intermediate or advanced skating skills following the Skate Canada Canskate instructional/badge system. Skaters are grouped based on age and ability. Helmets are mandatory. (Refer to Helmet Policy)

****** HELMET POLICY - NEW REVISED - May 2011 - Skate Canada National Policy ******

All Skate Canada member clubs and skating schools who offer a CanSkate program must ensure all CanSkate and Adult CanSkate participants up to and including Stage 5 must wear a CSA approved hockey helmet while on the ice.

Clubs and skating schools must ensure this policy is enforced during all skating activities including competitions, carnival days or any other special on ice activities throughout the season for this level of skater.

Clubs and skating schools may choose to expand the use of CSA approved hockey helmets in their club as they see necessary.

In general, anyone who lacks good control/balance when skating forward, backward and has difficulty stopping, as well as maneuvering around obstacles on the ice must wear a CSA approved hockey helmet.

The Goulbourn Skating Club reserves the right to make amendments to any or all schedules.

No fees will be levied towards any member withdrawing as a result of these changes.

Payment and Refund Policy:

Cheques must be made payable to the Goulbourn Skating Club. NSF cheques will be subject to a \$25 administration fee. No refunds will be given after **September 13th, 2011** unless accompanied by a medical certificate. NOTE – Skate Canada Fee (\$31) and Fundraising Fee Non-Refundable.

Withdrawal Policy:

Skaters may withdraw from registered sessions after the program start date for medical reasons. A refund of program fees, calculated on a pro rata basis, based on the number of sessions that have taken place up to the time of withdrawal and the number of sessions occurring after the withdrawal, will be given to the skater upon presentation to the Club Registrar of a medical certificate. Skaters who, for non-medical reasons, choose to withdraw from a registered program after the start date, will be entitled to a pro-rated refund, less a \$25 administration fee, as long as the withdrawal request is received during the first 4 sessions. If the request is made after this time, no refund will be given. No refund will be given to any withdrawn skater for any Skate Canada fees or fundraising fees as these amounts are paid by the Club to third party sources after registration and cannot be refunded to the Club.
